1. The prospective bidders interested to participate in the tender shall have to deposit sealed bid alongwith the Pay order / demand draft of Rs.50,000/= (Rupees fifty thousand only)in favour of Port Qasim Authority, Karachi to the office of Manager(Procurement),Stores Department on or before _____ at **1300** hours. Bids will be opened on the same day at **1400** hours in the Conference Room, Admin Building, Port Qasim Authority,in the presence of bidders or their authorized representative,who may wish to attend. The documents received after due date and time not be entertained.
2. Details of the above vehicles terms & condition of the tender can be collected from the office of Manager (Procurement) at Store Department ,PQA during office hours or may be downloaded from PQA/PPRA Websites.
3. The above Vehicles can be inspected on any working days between 09:30 hours to 15:30 hours except Saturday and Sunday / Holidays.
4. All applicable Government Taxes i.e GST & Income Tax will be required to be paid by the purchaser at prevailing rates.
5. Unsuccessful bidder's pay order refunded back after conclusion/finalization of the proceedings.
6. The bidders must satisfy themselves on all the points before bidding. After that no objection or query will be accepted. Interested parties can inspect the vehicles will be sold on the assumption that the bidder's has/have inspected the same and know what they are buying whether they have first inspected it or not.
7. Bidder must attach their CNIC Copy alongwith sealed bid.
8. All offers will be subject to the approval of the Competent Authority or his nominee and the offer will remain open until these are accepted or rejected.

The successful bidder will have to pay the full & final cost of the Vehicle as approved by the Competent Authority inclusive all taxes in shape of pay Order in favour of Port Qasim within Seven days (07) Days of issuing of acceptance latter otherwise the earnest money of Rs.50,000/= will be forfeited in favour of PQA.
10. Acceptance letter of successful bidder will be issued after clearance of the pay order in PQA Account.
11. All these vehicles will lie on the spot entirely at the risk of purchaser from the time, they are knocked down and must be removed/cleared within (15) days after receipt of full payment. Successful bidder/authorized person will arrange necessary equipment/labour at their own for lifting of these Vehicles from PQA.



12. Municipal dues , Excise , GST fee etc , if any , will be required to be paid by the seuccessful bidder/ authorized person on the items liable to such charge.
13. Incom Tex at prevailing rate on purchase money of all the items will be required to be paid by the successful bidder / authorized person.
14. Final delivery order and gate passes for the release of auctioned items will be issued by PQA, auctioned items will be released on production of receipt showing full payment of bid money and delivery order issued by PQA.
15. Port Qasim Authority reserves the right to accept or reject any or all bids / quotation as per PPRA-2004 and no claim what so ever will be entertain in this regard. Authority's decision in this respect shall be final and binding on all bidders.
