The Prospective bidders intending to participate in the open auction shall have to deposit a pay order / demand draft of Rs. 50,000/- (Rupees fifty thousand only) (Refundable) in favour of Port Qasim Authority, Karachi and obtain a token for participation till 3-5-2017 during working hours. Token will only be issued to the one authorized person having printed letter of the company & upon production of original CNIC along with photocopy. The prospective bidder reaching after time & date will not be entertained.

4. The detail of above material and terms and conditions of the auction can be obtained (free of cost) against token receipt, any working day from the office of Manager (Procurement) Stores Department, Port Qasim Authority or may be downloaded from PQA/PPRA websites for their information only.

5. Only one (1) authorized person will be allowed against token receipt to participate in the bid proceeding.

6. All applicable Government taxes i.e GST & Income Tax other taxes etc will be required to be paid by the purchaser at prevalent rates.

7. PQA reserves the right to accept or reject any or all offer ^{as per PPR-2004} and ~~no~~ claim what-so-ever will be entertained in this regard. Authority's decision in this respect shall be final and binding on all parties.

TERMS & CONDITIONS FOR OPEN AUCTION OF CARGO HANDLING EQUIPMENT

1. The Prospective bidders intending to participate in the auction shall have to deposit pay order/Demand Draft of Rs.50,000/- (Rupees fifty thousand only) (**Refundable**) in favour of Port Qasim Authority, Karachi and obtain token receipt of participation till _____, during working hours. The prospective bidders reaching after given time and date will not be entertained.
2. Only one (1) authorized person from each company will be allowed to attend the auction proceedings/collect token. Token will be issued to those personnel who have printed letter head of the company bearing complete details (Address, Telephone Nos. etc). The person collecting the token must have his Original CNIC and its photocopy readily available with him.
3. All personnel having token of participation shall remain seated on their allocated seats during the auction proceeding at all time. No discussion will be allowed during auction proceeding.
4. Unsuccessful bidder's pay Order will be refunded at the spot after conclusion of the proceedings.
5. Token money of successful bidder will be adjusted against 25% payment to be made on the spot.
6. The prospective bidders can inspect the articles/items at respective sites at Port Qasim Authority, Bin Qasim, Karachi-75020 on any working day between 0930 to 1530 hrs except Saturday & Sunday within fifteen(15) days up to _____ from the date of publication of the notice of auction in the newspaper.
7. Director General (Admin) of PQA or his nominee will reserve the right to place the items either in lot or lots of unit or as a unit.
8. Items are strictly to be sold on "**as is where is**" basis.
9. The bidder must satisfy themselves on all the points before bidding. No guarantee can be given. Interested parties can inspect the items. Items will be sold on the assumption that the bidder's has/have inspected the same and know what they are buying whether they have first inspected it or not.
10. Where required weight of the items/articles will be arranged at PQA Weighbridge and charges of the same will be made according by successful bidder / authorized person.
11. Bidders will have to bring their original CNIC along with photocopies and token receipt in original at the time of auction.

12. Attorneys, broker and other persons authorized to act as agent to bid, on behalf of company or principals, shall be bound to disclose the full name and status of their client or principals and shall furnish such information and documents required under orders of the Competent Authority before receipt of token of open auction.
13. All offers will be subject to the approval of the Competent Authority. The offer will remain open until they are accepted or rejected.
14. 25% of bid money must be paid in cash or through Pay Order, on the spot by the successful bidder to the PQA cashier, against proper receipt in quadruplicate (one for cashier, one for bidder, one for Stores Department and the fourth one for the PQA Auctioneer).
15. The balance amount 75% of the purchase money/bid must be paid in cash or in shape of Pay Order through challan in PQA Accounts within fifteen (15) days, after final acceptance of the bids. The copy of the challan will be issued by the Cashier/Store department, in the manner described above upon which the successful bidder will obtain delivery order to be issued by Auctioneer/ Stores Department.
16. If the bid is subsequently not accepted by the Authority, the deposit made by the bidder shall be refunded to him without interest. The decision of the Authority shall be binding and not liable to be challenged.
17. In case the successful bidder fail to make payment as specified above within the time laid down for the purpose, or within extended time as may be allowed, the amount of 25% deposit by him at the time of auction will be forfeited.
18. All items will lying on the spot entirely at the risk of purchaser from the time they are knocked down and must be removed/cleared within forty five(45)days after receipt of full payment. Successful bidders/authorized person will arrange necessary equipment/labour at their own for lifting of the items/materials from PQA.
19. Municipal dues, Excise, GET , Weightiest Charges of PQA weighbridge etc. if any, will be required to be paid by the successful bidder/authorized person on the material liable to such charges.
20. Income Tax at prevalent rates on purchase of all items will be required to be paid by the successful bidder/authorized person.
21. Final delivery order and gate passes for the release of auctioned items will be issued by PQA, auctioned items will be released on production of receipt showing full payment of bid money and delivery order issued by PQA Auctioneer.
22. Port Qasim Authority reserves the right to reject the highest or any other bid without assigning any reason/ground thereof.
23. PQA reserves the right to cancel/withdraw any items from the auction without assigning any reason whatsoever.
