The Prospective bidders who are interested to participate in the open auction shall have to deposit a pay order / demand draft of Rs. 1,000,000 (one million) (Refundable) in favour of Port Qasim Authority, Karachi and obtain a token for participation till **28<sup>th</sup> March 2017**. Token will only be issued to the one authorized person to participate in the auction proceedings upon production of token receipt original CNIC along with photocopy. The prospective bidders reaching after the given day and time will not be entertained.

Open Auction will be conducted on **29<sup>th</sup> March 2017** at 1100 hours at site Port Qasim Authority in the presence of bidders or their authorized representative, who have obtained the token may wish to attend.

## TERMS & CONDITIONS FOR OPEN AUCTION OF BER CRAFT

Port Qasim Authority (PQA) under Federal Ministry of Port & Shipping intends to disposal off "Motor Tug Chara , M.T Ghara & I.L Isaro" BER through open auction from the prospective bidders on "as is where is" with unused spare parts basis which are as under:

2. The Prospective bidders interested to participate in the auction shall have to deposit pay order/demand draft of Rs. \_\_\_\_\_ (Refundable) in favour of Port Qasim Authority, Karachi and obtained a token for participate till **28<sup>th</sup> March 2017**. Token will only be issued to the authorized person to participate in the auction proceeding upon production of token receipts, original CNIC along with photocopy.
3. Details of the above mentioned Tugs and terms & conditions of the auction can be collected from the office of Manger (Procurement) Stores Department, PQA during office hours or may be downloaded from /PPRAPQA Websites.
4. The above mentioned Tugs can be inspected by the interested parties on any working days between **09:30 hours** to **15:30 hours** except Saturday and Sunday upto **28<sup>th</sup> March 2017**.
5. The Auction will be conducted on **29<sup>th</sup> March 2017** at **1100** hours at site Port Qasim Authority, Karachi.
6. All applicable Government Taxes i.e. GST & Income Tax will be required to be paid by the purchaser at prevalent rates and clearance custom duty on their own risk and cost.
7. Pay order of unsuccessful Bidder's will be refunded back after conclusion/finalization of the proceedings.
8. The participant must satisfy themselves on all the points before auction. After that no objection or query will be accepted. Interested parties can inspect the Tugs. The Tugs will be sold on the assumption that the participant has/have inspected the same and know what they are buying whether they have first inspected it or not.
9. Participant must attach their CNIC's Copy alongwith pay order.
10. Items are strictly to be sold on "**as is where is**" with unused spare parts basis.



11. The weight of the item/article will be arranged at PQA Weighbridge and charges of the same will be made accordingly by successful bidder.
12. A token will be issued to one authorized person to participate in the auction proceeding upon production of token receipt, original CNIC along with photocopy.
13. 25% of bid money must be paid in cash or through Pay Order & cheque on the spot by the successful bidder to the PQA cashier, against proper receipt in triplicate (one for PQA Finance Department, second for PQA Stores Department and third for successful bidder).
14. The balance 75% of the purchase money/bid must be paid in shape of Pay Order through challan in PQA Account within thirty (30) days, after final acceptance of the bids. The copy of the challan will be issued by the Cashier/Store department, in the manner described above upon which the successful bidder will obtain delivery order to be issued by stores department.
15. If the successful bid is subsequently not accepted by the Authority the 25% deposit made by the successful bidder along with Rs.1,000,000/- token money shall be returned to him without interest. The decision of the Authority shall be binding and not liable to be challenged.
16. In case the successful bidder fail to make the balance 75% payment as specified above within the time laid down for the purpose, or within extended time as be allowed, the amount of 25% deposit by him at the time of auction along with Rs. 1,000,000/- token money will be forfeited.
17. All bidders having token of participation shall remain seated on their allocated seats during the auction proceeding and not be permitted to interrupt the auction by discussion among themselves or otherwise.
18. Attorneys, broker and other persons authorized to act on behalf of their clients or principals shall be bound to disclose the full name and status of their client or principals and shall furnish such information and documents as may be required under instruction or PQA before receipt of token/open auction.
19. The successful bidder will have to pay the full & final cost of the Craft after approval of the competent Authority inclusive all taxes in shape of pay order in favour of Port Qasim Authority within seven (07) days of issuing of acceptance letter or otherwise the token money of Rs. 1,000,000/- will be forfeited in favour of PQA.
20. Acceptance letter of successful bidder will be issued after clearing and crediting of the pay order in PQA Account.
21. The Craft will be lie on the spot entirely at the risk of purchaser from the time they are knocked down and must be removed / cleared with in forty five (45) days after receipt of full payment. Successful participant/ authorized person will arrange necessary equipment / labour at their own for towing the craft from PQA.
22. Municipal dues, Excise, GST etc. if any, will be required to be paid by the successful bidder/Authorized Person.
23. Income Tax at prevailing rates purchase money of all the items will be required to be paid by the successful bidder/authorized person.



24. Final delivery order and gate passes for the release of auction item shall be issued by PQA, auction item shall be released after full payment of offer money by the successful bidder/authorized person.

25. Port Qasim Authority reserves the right to accept or reject any or all offer as per PPRA-2004 and no claim whatsoever will be entertained in this regard. Authority's decision in this respect shall be final and binding on all parties.
