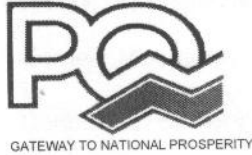
3. The bidding shall be by Single Stage One Envelope procedure under Rule 36(a) of the Public Procurement Rules-2004.

2. Details of the items/specifications alongwith terms & conditions of the tender can be collected from the office of Manger (Procurement) at Stores Department, PQA during office hours. The details of the items can be downloaded from PQA/PPRA Websites.
3. The method of procurement will be Single Stage one envelope procedure as a package under Rule 36(a) of the Public Procurement Rules-2004.
4. Tender without earnest money will not be accepted.
5. All type of taxes including GST and professional Tax etc. will be borne by the supplier.
6. Bidders will have to quote GST Number, NTN Number and enclosed copies of certificates.
7. Firm awarded the contract will be responsible to complete the supply as per Supply Order.
8. The validity of supply period is 60 days the date will be started from the date of issuance of Supply Order.
9. Sealed bids from the Manufacturers / authorized distributors / suppliers / contractors etc. registered with Income Tax and Sales Tax Department & GST to quoted rates as per specification mentioned are to be submitted.
10. Rates quoted must be valid for 120 days from the date of opening of the tender.
11. Rates quoted should be on the basis of free delivery and installation at Port Qasim Authority Stores Department Bin Qasim Karachi-75020 including all taxes and transportation charges.
12. Hundred percent (100%) payment will be made on completion of full supply and submission of bill in triplicate, Account No., Name of the Bank to be indicated on the body of the bill to facilitate payment.
13. Liquidated Damages at rate of 2% of the Contract Price per month maximum 10% of the Contract Price will be recovered if supply is not made within the contract period.

14. Only tenderers registered with NTN & General Sales Tax Collect-orate are eligible. Copy of the General Sales Tax Registration Certificate and Income Tax Certificate must be enclosed with the tender.
15. Earnest Money will be released after satisfactory supply.
16. Conditional tenders will not be entertained.
17. The proposal for award will be rejected if it is determined that the contactor/supplier recommended for award has been engaged directly or through an agent, in corrupt fraudulent, collusive or coercive, practices, as defined in the PPRA Rules-2004 while competing for the contract in question.
